## POSTAL HISTORY OF THE FINNISH MODEL 1930 DEFINITIVE STAMPS

THE GOAL OF THIS COLLECTION IS TO PRESENT A CROSS-SECTION OF THE POSTAL HISTORY OF THE FINNISH MODEL 1930 DEFINITIVE STAMPS THROUGH-OUT THE PERIOD OF VALIDITY OF THE MODEL 1.1.1930 – 31.12.1962

The validity of the model 1930 definitive stamps (M30) started on January 1<sup>st</sup>, 1930 and included overlap with the preceding M17 and with the subsequent M54 definitive issues. The validity ended officially on December 31<sup>st</sup>, 1962. The M30 postal history includes many short and difficult postal rates, rate combinations and a number of bilateral and international postal treaties. These include the Nordic Postal Union, bilateral agreements with Estonia and Latvia, and the war-time agreements with Germany, Hungary, the European Post and Telecommunication Union (EPTU). The exhibited items are examined by the type of mail, by postal rates, by routes and transport used, by the additional services or fees paid, and by the weight of the items. The UPU color specifications have also been taken into consideration. On some occasions the postmarks used and censorship is noted.

Rarity classification of the items is based on classifications used in previous exhibition collections and on the availability of similar items in auctions during the last fifteen years. Philatelic literature and especially the list of the rarest M30 postal history items by Kauppi (2012) have been used as guidelines. Rarity is based on, for example, on the shortness of the rate, rare fee or surcharge for a type of mail, rare type of mail, or a rare single use of a M30 stamp. In this collection an item marked RARE is an item that is one of ten or less similar items known to exist, or that is on the list of the rarest M30 postal history items. The collection includes twelve (12) items that are the only one known of their kind and over sixty (60) items that are on of less than five known items of their kind.

Every frame has two A3 size pages in the center that highlight special items, or a special topic connected to the general contents presented in the frame. A double titling system is in use, where a general indication of the type of mail is given in the first order title and a specification of the item on the second order title.

The collection has been developed further and <u>extended to eight frames from five frames</u> exhibited in Nordia 2016 (V) and in Finlandia 2017 (LV). Many new only registered and very rare items have been included, e.g., the only known third weight class letter with the special rate to Germany in 1943 and a very rare air mail document abroad.
